Who Can Join the Association?

Regular Membership: Any firm or individual supplying goods or services to the mining industry. Membership applications will be subject to approval by the MSABC Executives.

Associate Membership: Any firm that does not directly provide supplies or services to B.C. operations but provides supplies or services distributed through an existing MASBC member company.

The purpose of the Mining Suppliers Association of B.C. is to support and enhance opportunities for B.C. suppliers of goods and services to the mining industry.
